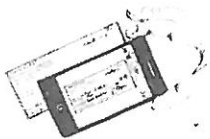

Beware of scams!

Phishing is a cybercrime where criminals provide false emails, websites and texts that lure individuals to provide personal sensitive information. Providing this information can result in identity theft and give criminals access to your financial information.

Helpful hints

- Be on the lookout for emails that have many grammatical errors and misspelled words.
 - If you don't recognize the sender, don't open the email.
- Suspicious attachments in an email, or requests to download suspicious attachments
 - Generic, almost robot type email and format

Protect Yourself

- Do not give personal or financial details in emails or text messages
 - If you do not know the sender, do not reply to the email
 - Do not open any attachments from an unknown sender
 - Download antivirus software from a trustworthy source
