## Be Cautious of Unemployment Scams

If you are applying for Unemployment Insurance, please be aware that scammers are taking advantage of the uncertainty caused by this pandemic. When filing, keep in mind the following:

- There is no fee to file for unemployment, do NOT send any money.
  - Only use the official DWS website to file for unemployment.
- Do not give out your personal information through social media, including Facebook Messenger.
  - Do not send your personal documents through email or upload them to any website. These documents should only be faxed to DWS.
- If you have NOT filed, yet receive a letter, direct deposit or debit card from Unemployment Insurance, report it to UI Fraud Immediately.
